**Terms and condition.**


1. The agency will submit an experience of not less than 2 (two) years of such type of work.

3. The Empanel Government approved Agency /Local Women SHGs should be submitted the Xerox copy of PAN card, EPF,ESI, Labour Licence certificate & registration certificate with the Bid document.
4. The bill in duplicate must submitted after approval of competent authority i.e. form I/C Health Officer or Sanitary Supervisor of this Municipality for payment at the end of the each month
5. The Empanel Government approved Agency /Local Women SHGs will responsible for any damage/ breakage of public property of the toilet.
6. The Empanel Government approved Agency /Local Women SHGs will provide bleaching powder, phenyl, brush, broom stick to the care taker for the cleaning of toilet every day. (including provision of all materials & sanitary)
7. The Empanel Government approved Agency /Local Women SHGs will pay electric bill to the PPT,
8. Minor maintenance will be borne by the Government approved agency/SHGs


