NOTICE

In pursuance to Housing & Urban Development Department letter no 13408/HUD, Dt. 30.7.19, it has been decided to deploy human resources (referred as 'Swachha Sathi' and 'Swachha Sathi Supervisor') on fixed term basis at house hold clusters (for cluster: 600 House holds one Swachha Sathi and one supervisor for cluster: 2400 i.e.), within Paradeep Municipality jurisdiction to facilitate and catalyse viz. door to door waste collection, waste segregation at source, functioning of MCC (Micro Composting Centre) through IEC/SBCC awareness tools.

The following human resources can be selected only if she is satiating following eligibility criteria:

- · She must reside in Paradeep Municipality area
- Must be a member of WSHG/ALF,
- Not having criminal track records and,
- Having educational qualification +2(for 'Swachh Sathi') and +3 or a graduate (for 'SwachhSathi Supervisor').
- She should be a good communicator having ability in community mobilisation, basic managerial skills, or prior experiences (not mandatory), which will be assessed (as per SOP on decentralised Solid Waste Managements, para-3 i.e. Assessment of Human Resources) during shortlisting of prospective applicants.

Evaluation of Applicants

Evaluation of applicants using a weighted system (out of 100 marks) that takes into account the following:

- In-person interview (40%)
- Job assessment/knowledge on waste management (30%)
- Work experience in community mobilization (20%)
- Education (10%)

Applicants with the highest combined scores will be called back for a second interview. After this interview, the hiring committee/panel (P1; P2; P3; P4) will confer and come to a consensus. The successful candidate will be contacted via phone and presented with an offer within 24 hours of the decision being made.

Interested candidates possessing the qualification may apply in prescribed formatwith applications complete in all respect along with attested copies of the certificates (one pasted photograph) as given below, to undersigned on or before 20th Aug 2019. The selected candidates will be briefed and trained, about the mandates job requirements by Sanitation expert and CO-SBM before final onsite-deployment.
